2	Clause 3.4.3 (Page 14): Payment will be released after completion of exercise for each batch/pool after review of the timeliness and quality of the deliverables committed to by the bidder. Please specify on the payment term. As per our company policy the payment term is 30 days from the submission of Invoice	The payment will be released within 30 working days from the date of receipt of invoice or clarifications on invoice, whichever is later.
3	Do we need to create a login for us in the MSTC portal – if so it should be in the vendor login right?	Yes
4	The RFP copy provided is in PDF format – will you share the word document since we have to submit the RFP in the letter head of our company?	No

12	On page 44 titled Annex 7 and page number 45 titled Annex 8: do we need to share the team composition details while submitting our proposal stage itself or this can be shared if we won the bid and awarded the contract?	Yes
13	Page 18, 5.1.1, the potential firm should be registered for 5 years. Is there is any relaxation possible?	No
14	In case more information is needed for background verification, can we approach the candidate?	In majority cases, the verification is to be done with recourse to the candidates. In a few cases, the verification has to be done discretely. The Bureau will specify the cases where such discrete verification is required.
